

INSTRUCTIONS TO AUTHORS

Scope and policy

The *Revista de Patologia Tropical* aims to spread knowledge in the field of transmissible disease agents and vectors in living beings and their public health consequences. In order to do so, this journal accepts original articles, communications (notes), case reports, updates and reviews, both in human and animal or plant, on topics of interest to the Tropical Pathology and Public Health areas, in English.

Manuscripts are peer-reviewed and are published only if they are accepted. The views expressed are the sole responsibility of the author and do not reflect the opinion of the Editorial Board. Authors should disclose any conflict of financial, personal or other relationships with people or organizations that could inappropriately influence the manuscript or be understood as such. In order to avoid malpractice and following international recommendations on plagiarism, articles may be submitted to the plagiarism editor for verification.

The manuscript submission must be accompanied by a letter signed by all authors stating the full name and email address, confirming that the material has not been published or is under consideration for publication elsewhere, and agreeing to transfer copyright in all media and formats for *Revista de Patologia Tropical*. Please submit, with the manuscript, the names and e-mail addresses of 3 potential referees. Note that the Editors retain the sole right to decide whether or not the suggested reviewers will be consulted.

Research involving humans or animals require a prior approval from the corresponding Ethics Committee.

Manuscript preparation

Manuscripts should be sent to the Journal of Tropical Pathology at the site: [http:// www.revistas.ufg.br/index.php/iptsp](http://www.revistas.ufg.br/index.php/iptsp) or by e-mail: revpatoltrop@yahoo.com.br.

The manuscript should be prepared using Microsoft Word software version 2003 or later, Times New Roman, size 12 space 1,5 throughout the text and margins with at least 3cm. The word limit is 4,500 with up to 6 insertions (figures and tables).

Original articles should have the following structure:

a) title b) author (s), c) e-mail of the corresponding author; d) scientific affiliation (department, institute, college, university, country), and) financing organ (if any); f) a summary (with a maximum of 250 words); g) key words (three to five); h) English title, abstract and key words i) introduction and objectives; j) materials and methods, k) results; l) discussion and conclusions m) acknowledgments, n) references o) figures and tables with their captions.

Citations: If the author's name is part of a sentence use the following format: a) with one author Dubey (2003), b) with two authors: Borges & Mendes (2002) and more than two authors: Borges et al. (2007). Footnotes should be avoided.

References should be presented in alphabetical order, numbered in ascending order, with input by the last name (s) of author (s). When more than one work by the same author cited, the citation should follow the chronological order of publication. References examples

c) dissertation / thesis: Spadeto AL. Efficacy of benznidazole in treatment of children with chronic infection with *Trypanosoma cruzi* after 6 years of follow-up: A randomized

controlled trial, double-blind, placebo-controlled trial. Goiânia [Dissertation in Tropical Medicine - IPTSP / UFG], 1999.

d) book: Smith PG, Morrow RH. *Field Trials of Health Interventions in Developing Countries: A Toolkit*. OPAS. Washington, 1998.

e) book chapter: Prata A R. Mansonic Schistosomiasis. In: Veronesi R. *Infectious and Parasitic Diseases*. Guanabara-Koogan. Rio de Janeiro, 1991.

References should conform to the requirements used for manuscripts in biomedical journals (Consult: <http://www.nlm.nih.gov/citingmedicine>). The titles of the journals should be abbreviated according to the style used in the Index Medicus. Consult: <http://www.ncbi.nlm.nih.gov/sites/entrez?db=journals&TabCmd=Limits>.

Other types of manuscripts other than original articles such as communications (notes), case reports and updates should not necessarily follow the structure described above.

The illustrations should be sent separately and must meet the quality standards necessary to allow a good reproduction. Digital images, JPEG format, should be approximately 300 dpi resolution, 11 cm wide and should be designated as figure (Figure 1, Figure 2 ...) in the text. Tables should be executed on the same software used in the preparation of text. The color photographs are available in the online version of the Journal. The print version of the photographs will be in black and white. However if the authors opt for the colored version of the photographs also in the print version the extra costs of the colour offsets reproduction will be of the author's responsibility.

Acceptance of the manuscript

The manuscripts will be accepted after compliance with all stages of processing. All manuscripts will be submitted to the reviewers of Portuguese, Spanish and English languages with experience in publications in the area.
